

Our Safety & Health Protocols

- Cleaning frequency and additional disinfection will be performed on high touch areas like door handles, restrooms and public areas

- Additional sanitization products will be placed at entrances and in high traffic areas.
- We limit single use items at catering stations whenever possible. When possible, composable single use items to be used to reduce multiple touches.
- Restrooms are equipped with touch-less sinks and soap dispensers



Meeting Registration and Arrival

- Masks are required for attendees upon entry and provided for any attendee who wants one at the entrance or registration.
- •Social distancing is required at check-in through floor decals and posted signage to ensure a safe check-in.

Requirements: Proof of Vaccination, Negative COVID Test Result & Daily Questionnaire

All guests attending an onsite event are required to provide proof of a negative Rapid COVID-19 test taken within 48 hours of the event, as well as proof of full vaccination (2 or more weeks have passed since your final dose of the COVID-19 vaccine).

- 1. All visitors must complete a <u>visitor questionnaire</u> out of an abundance of caution **on the day of the event** using an online form **ahead of anticipated arrival**. The questionnaire will determine if a guest meets Nasdaq's requirements to access the facility.
- All visitors will be asked to present a negative Rapid COVID-19 test result (within 48 hours of the event) and proof of full vaccination (2 or more weeks have passed since your final dose of the COVID-19 vaccine) to Security upon arrival.
- 3. All visitors will be asked to present photo identification along with the required proofs for verification.

Accepted Forms of Proof

Nasdaq accepts all CDC approved vaccines. CDC approved vaccines in the U.S. found here. Accepted forms of proof include:

- your physical vaccine card
- your digital vaccine card or digital passport
- a photo of your vaccine card

Nasdaq prefers a clinical test as the best form of proof of a negative Rapid COVID-19 test result; however, we will make exceptions for over the counter, at-home COVID-19 test results as well. Accepted forms of proof include:

- your printed form of proof from a testing clinic
- a photo of your printed proof from a testing clinic
- a photo of your negative OTC, at-home COVID-19 test alongside your photo ID captured in the photo

Face Coverings

As stated above, masks are required upon entry during our initial check-in period.

- Once proof of a negative Rapid COVID-19 test, proof of full vaccination along with completion of the visitor questionnaire is provided to security, masks can be removed for the remainder of your time within Nasdaq's facilities.
- You may be asked to replace your mask when traveling through the lobby and elevators.

Local Compliance

- Guests must comply with all New York State and New York City quarantine rules regarding individuals who have travelled domestically or internationally.
- Guests must comply with all wellness protocols and social distancing controls.
- A maximum of four people or one party is allowed in our elevators at a time. Guests are encouraged to use the stairs wherever possible.
- If any Guests are experiencing symptoms of COVID-19 while at MarketSite or upon their departure we ask them to please leave immediately to quarantine and to notify your Nasdaq representative to ensure contact tracing is properly administered. Symptoms of COVID-19 can be found here.
